**CHARACTERISTICS OF THE CLASS:** Works under the immediate supervision of an Airport Firefighter Supervisor. Responsible for timely response to all emergency situations within established emergency response and recovery guidelines; enforcing airfield security, operations and maintenance standards and regulations; building, grounds, and equipment maintenance and repair.

**EXAMPLES OF DUTIES:** Performs work in aircraft rescue and fire fighting; emergency medical technician (EMT) duties if certified; airport operations; airport, building, grounds, and equipment maintenance and repair; snow removal; and airport security. Responds to aircraft accidents and extinguishes fires of highly volatile aircraft fuels, rescue and administers medical treatment to persons involved, and fire and medical incidents in and around airport buildings and facilities. Wears protective clothing and uses specialized equipment for fighting and extinguishing fires, rescuing individuals trapped in burning or crashed aircraft and administering medical treatment. Inspects airfield and navigational aids for compliance with established standards and regulations. Conducts regular inspections of all structures at the airport for compliance with established fire safety and security policies. Assists in building, grounds, and equipment maintenance and repair. Performs general housekeeping duties. Assists as needed, in new building and construction work. Performs related work as required.

**WORK CONDITIONS:** Exposure to hazardous materials and conditions; required to be able to use and/or wear a variety of safety equipment; required to work in adverse weather conditions.

### **KNOWLEDGE, SKILLS AND ABILITIES:**

**Knowledge of:** fire fighting techniques and equipment; modern fire rescue methods and equipment, and emergency medical techniques; maintenance procedures on the various types of fire fighting and fire rescue equipment; methods and practices applied in generalized preventative maintenance, repair, remodeling and construction activities; maintenance, and grounds machinery and equipment.

**Skill/Ability to:** fight various types of fires; administer emergency medical care; act quickly and calmly in emergency situations; operate assigned fire fighting equipment; perform generalized preventative maintenance, repair, remodeling and construction activities; operate motorized vehicular equipment.

**SPECIAL SELECTION FACTORS:** Possession of a current Arizona Driver's license appropriate to the assignment at time of appointment. Must possess a current Firefighter 1 & 2 Certification at time of appointment. One year of experience as a professional fire fighter. A medical/physical evaluation is required prior to appointment. EMT Certification is preferred at time of hire, must be obtained within first year of hire. Employees in this classification will serve an initial probationary period of one year.

Any combination of training and experience that meet the knowledge, skills, and abilities (KSAs) may be substituted.
